Authorize the CEO to execute a Letter of Intent and accompanying term sheet with one of the developers listed in 1 above (MarVentures/Continental, ESL/NexCore or Sunrise) who, in the judgment of the CEO after considering the input from the Advisory Working Group and the Board, offers the most favorable terms to the District and the communities it reserves consistent with the criteria for selection. 3.
