8.B DESIGN REVIEW FOR BUILDING ADDITION AND EXTERIOR ALTERATIONS ON A CONTRIBUTING RESIDENCE AT 325 EAST K STREET

The applicant requests design review approval for a building addition and related exterior alterations to a contributing residence in the Downtown Historic District. The proposed alterations include an upper-story building addition that would alter the existing roofline. The addition would be clad in wood lap siding and would include five new wood windows and two skylights. Additionally, the applicant proposes replacement of an existing door on the north (rear) of the structure and installation of a new window on the lower, rear portion of the west (side) elevation.

RECOMMENDATION:

Adopt the resolution approving the design review application for an upper-story building addition and associated alterations, based on the findings and subject to the conditions listed in the proposed resolution, after a public hearing and determination that the project is exempt from CEQA.

Pursuant to Government Code Section 65009, if you challenge a decision of the City Council in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City Council at, or prior to, the public hearing. You may also be limited by the ninety (90) day statute of limitations in which to challenge in court certain administrative decisions and orders (Code of Civil Procedure 1094.6) to file and serve a petition for administrative writ of mandate challenging any final City decisions regarding planning or zoning.

The decision of the City Council is final as of the date of its decision unless judicial review is initiated pursuant to California Code of Civil Procedures Section 1094.5. Any such petition for judicial review is subject to the provisions of California Code of Civil Procedure Section 1094.6.
