Please indicate which option you choose by checking the appropriate box on the "Request to Speak" Form. Agenda Items for which citizens' comments are not permitted are noted in the left margin of the Agenda. In general, these will be items on which a public hearing has previously been held. If you wish to speak on a topic concerning the City that is not on the Agenda, please indicate the subject you wish to discuss on the "Request To Speak" Form. When your name is called, please come to the Commission table and first state your name for the record. Please remember that there is a time limit of three minutes.

The City Auditor and Clerk will forward all Request to Speak forms to the Mayor. When the Mayor calls your name, come to the Commission table, and restate your name for the record. We ask that your comments be limited to the subject of the Agenda Item. Remember, we are always happy to listen to your comments; however, this is not intended to be an extended question and answer session.
