6.A. 215 Sausalito Boulevard | Design Review | Project ID: 2023-00026 | APN: 065-263-10 | Matthew Mandich, Associate Planner

SUMMARY: The Applicant, Christopher Sullivan / Long Water Trust, is proposing a new two-unit development project with an accessory dwelling unit at 215 Sausalito Boulevard ("the Project"), submitted pursuant to Government Code Section 65913.4 (originally enacted by SB 35).

RECOMENDATION: Staff recommends that the Planning Commission deny application 2023-00026 for 215 Sausalito Boulevard and adopt the attached draft resolution of denial. The Project as proposed would violate the applicable height limit, floor area ratio, maximum coverage, impervious coverage, side setback, and rear setbacks that apply to the parcel under the General Plan and applicable City zoning.
