#### 1. Call to Order

The Shoreline Task Force of the City of South Padre Island, Texas, held a special meeting on Tuesday, July 15th, 2025, at the Municipal Complex Building, 2nd Floor, 4601 Padre Boulevard, South Padre Island, Texas.

Chairman Stormy Wall called the meeting to order at 3:28 p.m. A quorum was present with Vice Chairman Abbie Mahan and Task Force Members Todd Williams, Michael Sularz, Stephen Murphy, and Chuck Fox.

Steve Mercer gave an update on the mitigation happening at 8454 Breakers Blvd. The mitigation has been successful so far. There has been little loss of dunes, and an extra 80 cubic yards of sand was added. We are now waiting for the plants to grow to complete the mitigation.

# 5.1.Discussion and action to provide a recommendation to City Council regarding the bids received for the Marisol (Laguna Madre) Boat Ramp. (Boburka)

Shoreline Director Boburka went over the bids for the Marisol Boat Ramp project. Bryant Industrial Services LLC (BIS) bid 1,760,917.83 for 240 days. Foremost Paving Inc. bid 2,164,093.08 for 1 year. Jerdon Enterprise LP. Bid 2,365,673.20 for 280 days. The bid rankings were scored using a task force made up of Shoreline Director Kristina Boburka, Coastal Coordinator Emily Kornblum, Shoreline Task Force Vice Chairman Abbie Mahan, Shoreline Task Force Member Fox, and Project Manager Manuel Guerra III. Given the bids and the bid scoring, the task force recommends BIS for the project.

Shoreline Task Force Member Williams motioned to recommend BIS for the Marisol Boat Ramp construction to City Council, seconded by Task Force Member Murphy. The motion passed unanimously.

# 5.2.Discussion and action to provide a recommendation to City Council regarding the submission of the National Fish and Wildlife Foundation's National Coastal Resiliency Fund grant proposal. (Boburka)

Shoreline Director Boburka gave an update on the NFWF proposal for dune restoration. The pre-proposal was accepted, so now the full proposal needs to be submitted. This project will construct sand fencing for the southern two miles of beach in order to capture sand for larger dunes.

Shoreline Task Force Member Fox motioned to approve the consent agenda, seconded by Task Force Member Sularz. The motion passed unanimously.
